- I understand and agree that if the applicant I am sponsoring is accepted as a Green Member,
- I am fully responsible for the applicant’s obligations to Modo;
  - Modo can place liens against my shares for debts due and owing from the applicant so long as the debts relate to use of Modo Vehicles that occurs prior to:
    - o The applicant terminating his or her membership;
    - o The applicant becoming a full member.
  - A Green Member is subject to an increased Damage Fee (as posted at modo.coop), is not eligible to participate in Modo’s Damage Pool and is required to make a Damage Deposit (as posted at modo.coop) before the Green Member may use a Modo vehicle.

- I confirm that,
- I am at least 25 years old and have a valid ICBC-issued Class 1, 2, 3, 4 or 5 driver’s license;
  - If the applicant is the holder of a learner’s L license and becomes a Green Member, I will only permit the Green Member to drive a Modo vehicle when accompanied by a Modo member that meets the criteria of a “qualified supervisor” (per ICBC definition), when the vehicle is used during a lesson with an accredited driving school or during an L driver’s “N” road test.
