### Definitions in this Agreement:

**Modo:** Modo Co-operative

**Partner User:** A person benefiting from the use of Modo, by their affiliation with the Partnership Member

**Partnership Member:** A property owner, strata corporation, organization or university that holds shares with Modo so that its residents, employees or students may access Modo vehicles at Modo Plus rates without paying membership fees themselves

I have read and understood Modo's [Price List\\*](#) and [Carsharing Handbook\\*\\*](#) ("the Handbook"). I agree to observe and be bound by these documents, including any amendments to them.

My acceptance is subject to my affiliation with the Partnership Member and a successful check of my driver's licence, driving record and insurance claims history.

### Conditions of Use

This agreement and the term hereby created shall be subject to the conditions herein set forth, and at the option of the Partnership Member, shall cease and determine if I breach or fail to observe or comply with any of the obligations herein.

- Provide me with access to Modo vehicles owned, leased or rented by it, and
- Pay for Modo vehicle related expenses such as gas, tires, maintenance and pre-approved repairs.



I understand that Modo will endeavour to ensure its vehicles are reliable and well maintained and will periodically inspect them. However, I recognize that:

- Partner Users share in the responsibility for the maintenance, care, safety and security of Modo vehicles;
- Modo's periodic inspection of its vehicles is supplementary to the inspection by Partner Users, who are required to check for and report damage and issues;
- Modo does not make any representations or warranties as to the fitness of condition of Modo vehicles.

Modo is committed to your privacy. We won't sell or trade your information to anyone or send you anything without permission. You can opt to not provide some or all of the information requested, but it could make you ineligible for full access to available services.
